



Subject: By-law modification

Date: March 21,2023

Current:

Article V – Section I HST Officers

- 3. Nominations for Officers shall be opened at the February meeting of every other year, and prior to the HST Annual meeting.
- 4. Elections for officers shall be held at the HST Annual Meeting during an election year, which shall alternate with the election year of the Board of Directors.

Modification:

- 3. Nominations for <u>affected</u> Officers shall be opened at the February meeting of every other year, and prior to the HST Annual meeting.
- 4. Elections for officers shall be held at the HST Annual Meeting. <u>The officer elections shall be grouped as President and Treasurer</u>, and the following year Vice-President and Secretary

Current:

- 3. Nominations for the (3) members-at-large shall be opened at the February meeting of every other year, and prior to the Annual meeting.
- 4. Election of the (3) HST members-at-large shall be held at the Annual Meeting during an election year, which shall alternate with the election of HST officers.

Modification:

- **4.** Nominations for the members-at-large shall be opened at the February meeting of every other year, and prior to the Annual meeting. One-member at large nomination / election should be grouped with the President / Treasurer nomination. The other two at large member nominations will be grouped with the Vice-President / Secretary position.
- 5. Election of the HST members-at-large shall be held at the Annual Meeting.

Nominations:

Current board members, Mark R., Trevor M. and Scott H.

March Meeting nominations are as follows for 3 board members.

- o Mike R Nominated, however declined at this time.
- o Mark R Nominated, with the exception of if no one else presented themselves.
- o Trevor M Nominated, however not present to decline, or accept.
